

Family Odyssey (Parent company TSNE Trading LLC) Terms and Condition

Arbitration Clause: These Terms of Use for Foursquare Consumer Services include a provision requiring arbitration for dispute resolution. Except for specific disputes explicitly exempted in the arbitration section, both parties agree to resolve disagreements exclusively through binding arbitration. Additionally, any right to join a class-action lawsuit or participate in a class-wide arbitration is expressly waived.

Terms of Use: The Family Odyssey Terms of Use (“Terms”) constitute a legally binding agreement between you and TSNE Trading LLC (“we” or “us”). These Terms govern your use of specific websites (including the Family Odyssey website), applications (such as the Family Odyssey app), services, content, features, and widgets provided by us (collectively referred to as the “Services”). Unless explicitly stated otherwise, this agreement does not confer any rights to third-party beneficiaries.

Please note that these Terms do not apply to any enterprise-level services or platforms we may offer. For such services, refer to the applicable Enterprise Service Terms. It is your responsibility to carefully review and understand these Terms before using our Services.

1. Agreement to Terms

1.1 Acceptance of Terms

By signing up for or using Family Odyssey’s services, including but not limited to browsing our website or engaging with our mobile application, you acknowledge that you have read, understood, and agree to these Terms of Use. If you do not agree with any part of these terms, you are not permitted to use the Family Odyssey services.

1.2 Applicability of Terms

These Terms govern all aspects of Family Odyssey’s offerings, including its websites, applications, and features. They apply to all users, including individuals posting reviews, sharing information, or contributing content, as well as businesses and venues interacting with the platform.

1.3 User Eligibility

Any activity carried out under your account will be considered your responsibility unless you promptly notify Family Odyssey of unauthorized access or potential security breaches. If your mobile number changes, it is your responsibility to update your account within 48 hours to avoid service interruptions. Please note that standard messaging and data rates from your carrier may apply when using Family Odyssey on mobile devices.

1.7 Electronic Communications

By using Family Odyssey, you consent to receive notifications, agreements, and updates electronically via the email address associated with your account. These electronic communications satisfy any legal requirement for written notice.

1.8 Service Termination

Family Odyssey retains the right to limit, suspend, or terminate your access to all or part of the platform at any time, with or without notice. Termination may result in the loss of access to your account and its data. You may voluntarily terminate your account by following the instructions provided in the application. All fees paid for services, if any, are non-refundable. 1.10 Restricted Activities

- Violate local, state, national, or international laws.
- Exploit the platform for unauthorized commercial or promotional purposes.
- Use bots or automated methods to interact with the platform.

1.11 Community Conduct

2. Content, User Contributions, and Limitations

2.1 General Content Overview

You agree not to:

- Bypass any restrictions, security features, or access controls implemented by Family Odyssey.

6. Additional Features and Use Terms

6.1 Integration Tools
